Terms and Condition of Automotive Battery Warranty

The batteries are warranted against faulty due to workmanship and material defects only. Depending on the battery and application the amount of time covered varies, refer to the table below for details.

In the event of the battery is defective (NOT include the warranty exclusions specified below), the battery should be returned with proof of purchase to the original distributor for testing. Subject to testing by the distributor the battery will be exchanged free of charge or get full refund.

Important-Exclusions

This warranty excludes batteries fitted as Original Equipment or used on the following applications:

- Cars used on a 2 or 3 shift/day basis.
- Taxi cabs (including private cars used as taxis or for private-hire).
- Ambulances. Police cars. Fire-engines.
- Televisions.
- Emergency lighting.

Batteries used in above applications carry a 6 month Warranty against faulty material. This Warranty is valid only for the purchaser of the battery, and is not transferable.

This warranty does not cover:

- Normal wear and tear.
- Batteries which have been subjected to deliberate abuse.

- c). Negligent and improper storage, usage or installation.
- d). Conditions resulting from abnormal wear, negligence, alterations or accidents.
- e). Incorrect fitment
- f). Batteries used in an incorrect application or batteries that are not used for their intended purpose.
- g). Unauthorized modifications to the battery.
- h).The use of so-called means of improvement

The warranty period is deemed to start from the date of the battery received by the importer.

Initiating a claim

If a battery fails within the specified warranty period as a result of a manufacturing or material fault, consumers should:

- a). Stop using the battery
- b). Advise the seller as soon as possible
- c). Look after the goods until they are returned
- d). Return the battery, including proof of purchase

When batteries are claimed under warranty period, the seller is entitled to ask for proof of purchase and consumers are obligated to provide. The seller must make detail record based on BATTERY WARRANTY CLAIM SHEET required information.

If the claimed battery quantity under warranty condition and within warranty period reach and above 1% of the total order quantity and after our final confirmation, the failed batteries could be get refund directly or deduct the equivalent mount from next order.

We would especially like to draw our customer attention to the fact that the period of use, temperatures and the application of the battery play a crucial role in determining whether it attains its maximum service life. Authorising a claim should always take place with this in mind.
